AN ORDINANCE OF
THE TOWN OF SECAUCUS, NEW JERSEY

ORDINANCE NO. 2023-1

AN ORDINANCE AMENDING SECTION 127-58B OF THE CODE OF THE TOWN OF SECAUCUS ENTITLED "DESIGNATION OF LOCATIONS AT OR NEAR PRIVATE RESIDENCES"

SECTION 1

NOW, THEREFORE, BE IT ORDAINED, by the Mayor and Council of the Town of Secaucus that Section 127-58B - "Designation of Locations at or Near Private Residences" shall be amended by adding the following location:

<u>NAME OF STREET</u>	<u>SIDE</u>	<u>LOCATION</u>
Fourth Street	West	On the west side of Fourth Street, beginning at a point 25 feet south of the southwest corner of Front Street and Fourth Street, continuing south for a distance of 18 feet in front of 781 Fourth Street
Centre Avenue	North	On the north side of Centre Avenue, beginning at a point 116 feet west of the northwest corner of Centre Avenue and Eighth Street, continuing west for a distance of 18 feet in front of 350 Centre
Humboldt Street	North	On the north side of Centre Avenue, beginning at a point 116 feet west of the northwest corner of Centre Avenue and Eighth Street, continuing west for a distance of 18 feet in front of 350 Centre

That the parking space designated for 781 Fourth Street adopted by Ordinance is to be personalized for Placard Number P2489003.

That the parking space designated for 350 Centre Avenue adopted by Ordinance is to be personalized for Placard Number P2219285.

That the parking space designated for 766 Humboldt Street adopted by Ordinance is to be personalized for Placard Number P2212641.

BE IT FURTHER ORDAINED, by the Mayor and Council of the Town of Secaucus that Section 127-58B - "Designation of Locations at or Near Private Residences" shall be amended by deleting the following location:

<u>NAME OF STREET</u>	<u>SIDE</u>	<u>LOCATION</u>
Eighth Street	East	On the east side of Eighth Street, beginning at a point 108 feet south of the southeast corner of Eighth Street and Centre Avenue, continuing south for a distance of 22 feet in front of 736 Eighth Street

SECTION 2

SEVERABILITY

BE IT FURTHER ORDAINED, that the provisions of this ordinance are separable and if any provision, clause, sentence, subsection, word or part thereof is held illegal, invalid, or unconstitutional, or inapplicable to any person or circumstance, such illegality, invalidity or unconstitutionality, or inapplicability shall not affect or impair any of the remaining provisions, clauses, sentences, subsections, words, or parts of the regulation or their application to other persons or circumstances. It is hereby declared to be the legislative intent that this ordinance would have been adopted if such illegal, invalid, or unconstitutional provision, clause, sentence, subsection, word or part had not been included therein, and if such persons or circumstances, to which the ordinance or part thereof is held inapplicable, had been specifically exempted therefrom.

SECTION 3

REPEALER

BE IT FURTHER ORDAINED, that all other ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed, to the extent of such inconsistency.

SECTION 4

EFFECTIVE DATE

BE IT FURTHER ORDAINED, that this ordinance shall take effect upon passage and publication as provided by law.

2. In the absence of the Mayor and the Senior Council Member, the members of the Council may appoint one of its members as chairperson.

3. The order of business shall be as follows:

1. Roll Call
2. Opening Statement - Open Public Meetings Law Statement
3. Approval of Minutes

4. Receipt Open and Reading of Bids - the Mayor and Council have the option of opening bids during a public meeting of the Mayor and Council or during the regular business day in the presence of the Purchasing Agent, Town Clerk, Town Administrator and Town Attorney.

5. Ordinances - Introduction and Hearing
6. Consent Agenda
 - Resolutions
 - Payment of Claims
7. Bingo & Raffle Applications
8. Communications Requiring Action by Mayor & Council
9. Committee Reports
10. Unfinished Business
11. New Business
12. Remarks of Citizens
13. Adjournment

4. The order in which the roll call and votes shall take place shall be as follows: The Mayor shall be called last. The Council Members shall be called in order of seniority. In the case of Council Members with the same seniority, the first member to be called will be determined by the alphabetical order of the surnames.

5. No motion shall be stated from the Chair, unless moved by one member, and seconded by another.

6. When a question is before the meeting, no motion shall be received except:

- 1st: To adjourn
- 2nd: To lay on the table
- 3rd: Ordering the previous question
- 4th: To postpone for a specific time
- 5th: To commit or amend
- 6th: To postpone indefinitely

All of these motions to have preference in the foregoing order. More than two amendments shall not be appended to a single question at the same time, the last amendment being denominated as an amendment to an amendment.

7. If the mover of a question accepts an amendment and no one objects thereto, it shall become part of the original motion without further form.

8. Prior to the vote on any questions, with the exception of Privileged Motions as defined in Robert's Rules of Order Revised, the chair shall ask if there are any questions or discussion regarding the motion. During this period, the Council Members may solicit any additional information or make a clarification of their feelings on the motion. Further discussion of the motion during roll call shall be restricted.

9. When a Member is about to speak in debate or communicate any matter to the Board, he/she shall respectfully address the Mayor and shall avoid all passionate language, personal or unparliamentary words. Every member of the Council shall have the privilege of speaking twice on any question but not again without permission of the Mayor.

10. Any citizen shall have the privilege of addressing the chair under Remarks of Citizens. A citizen shall have the privilege of speaking twice on the same subject but not again without permission of the Chair. However, no citizen shall speak more than five minutes on the same subject without permission of the Mayor. A citizen who has held the floor for five minutes or more shall yield the floor to any citizen who, having not been previously heard, requests permission to address the Chair. The Mayor shall have the right to determine when any citizen has abused the privilege under Remarks of Citizens and shall order such person to relinquish the floor.

11. If any member transgresses the rules, the Mayor and Council Members so called to order shall immediately sit down. The Mayor and Board of Council, if appealed to by the transgressor, shall decide the case by a majority vote, but without debate. If the appeal shall be in favor of the appealing member, then they shall be at liberty to proceed; if otherwise, they shall not be permitted to proceed. If the case requires it, the member who transgresses the rules shall, by a majority vote of the Mayor and Board of Council, be liable to censure of the Council, ejection, or be brought to the bar upon charges.

12. Any member may appeal from the Mayor's decision on a question of order, when without debate the Council Members shall demand it. Said question of order shall be decided by a majority vote of the Mayor and Board of Council.

13. The ayes and nays when taken shall be recorded in the minutes.

14. Minutes of meetings of the Mayor and Board of Council shall be approved no later than every two months.

15. Robert's Rules of Order Revised shall, in all cases, when not in conflict with the Statutes and Laws of New Jersey, or the Rules of the Town Council, be considered and held as standard authority regulating the parliamentary procedure of the Town Council.

16. Consent Agenda - all matters listed under Consent Agenda are considered to be routine by the Mayor and Council and will be enacted by one motion. There will be no separate discussion of these items. If discussion is desired, that item will be removed from the Consent Agenda and will be considered separately.
